## 1. PAY CONFIRMATION

If you're currently employed (hourly or salaried, full or part-time), please provide one of the following:



Your two (2) most recent pay stubs, with your name, the name of your employer, your hourly rate, the

number of hours you worked during the pay period, and the pay period itself.



If you do not have access to paystubs, a bank statement with your name, the name of the banking

institution, and two (2) months' worth of deposits from your employer, with their name as the depositor. Note: we cannot accept mobile banking screenshots.



A letter from your employer, which must be on company letterhead and signed by either the hiring manager or

human resources representative. Letter must confirm employment is ongoing and include your annual pay.



#### 2. TAX RETURNS

**If you're self-employed**, please provide a copy of the previous year's tax return.



## 3. INCOME SUPPORT PROGRAM **DOCUMENTATION**

If you're on income support, please provide a letter from your income support worker as well as a copy of documentation from the supporting program or agency (on agency letterhead) with your name clearly stated. The copy of documentation must state how much funding you're entitled to each month and outline how long you're entitled to remain on the program.

#### 4. RETIREMENT INCOME

If you are receiving retirement income, please provide documentation outlining how much you'll receive during the upcoming year from retirement benefits, which could include;



Canada Pension Plan (CPP) or Old Age Security (OAS): Include your schedule of payments from the Canada

Revenue Agency (CRA). This is mailed out each year or can be downloaded from the CRA My Account website.



**Retirment savings account payments** (monthly or annual): Include your

Statement of Retirement Income from a bank or investment firm.



**Invesment Account Payments** (monthly or annual dividends, distributions from Trust Units,

or other proceeds): Include your Statement of Investment Income from a bank or investment firm.



#### 5. PROOF OF STUDENT LOANS

If you're a student, please provide documentation outlining how much you'll receive in student loans for the upcoming year and:



Whether there are restrictions regarding how much you're allowed to spend on rent and living expenses (this will be the qualifying criteria for your application)



If there are no restrictions, please provide proof of enrollment to your post-secondary institution with your name clearly displayed, indicating expected tuition for the current or upcoming school year.



#### **6. STATEMENT OF SAVINGS**

If you're planning to use savings, please provide a copy of a bank or investment statement - on letterhead from your banking institution - with your name and a summary of holdings.
