Metergy will issue regular monthly bills with a due date being twenty (20) days after the bill creation date. Metergy will obtain my authorization for any other one-time or sporadic debits. I may change or revoke my authorization at any time, subject to providing notice to Metergy at least thirty (30) days before the next debit is scheduled. Metergy may not assign this authorization, whether directly or indirectly, by operation of law, change of control or otherwise, without providing at least ten (10) days prior written notice to me. I understand and acknowledge that this agreement solely governs the method of payment for charges arising under my Metergy account. Cancellation of this agreement does not constitute cancellation of services by Metergy nor in any way affect my obligation to pay for any and all charges associated with my Metergy account. I have certain recourse rights if any debit does not comply with this agreement. For example, I have the right to receive reimbursement for any debit that is not authorized or is not consistent with this PAD Agreement.
